The national parliaments that emerged from the process of the French Revolution were a key event in the development of liberal thought. With the 18th century well established, it was possible to debate the relative merits of a new, liberal conception of politics in the United States, in comparison with that of the British political tradition. ( . 4th Edition, pp. 149–151. The chapter concludes that Rousseau's political philosophy is the most liberal and optimistic in his own work. Rousseau also draws on Aristotelian and ancient political theory to reinforce his own position. As opposed to Hobbes and Locke, Rousseau holds that it is the people themselves who have the legitimate right to change the government through an amalgamation of various social groups. Rousseau is "at one with" Hobbes on the issue of the legitimacy of the political authority of the sovereign. Yet, Rousseau's conception is also more radical than Hobbes's, because Rousseau believes that sovereignty resides ultimately in the people themselves. In addition, Rousseau seems to put a higher priority on the rights of the individual, and on individual liberty, than Hobbes.

Rousseau's political thinking is an important influence on the American Declaration of Independence, which Rousseau drew on.<sup>4</sup> Rousseau is also widely considered to be the first "liberal" (from the Latin *libertas*) because
