There are various types of tubular containers. For some purposes it is desirable to produce a tubular container from a flat strip of material, such as a strip of aluminum sheet stock, having a uniform width. One such use for a tubular container is to produce tubular interlock panels. In such a use, a tubular interlock panel, composed of several layers, is commonly provided with a pair of anchoring areas, one at the top end and one at the bottom end, which anchoring areas are formed by means of cutting and scoring through the top and bottom ends of the panel. The anchoring area at the top end of the panel is called a TOP anchoring area, and the anchoring area at the bottom end of the panel is called a BOTTOM anchoring area. In such cases, the strip of material for forming the panel has a groove in the top surface thereof which is wider than the strip. The TOP anchoring area and the BOTTOM anchoring area are formed in the top and bottom of the strip of material which is wider than the strip of material
