Description of the Prior Art The traditional LCD is characterized by its features such as low power consumption, light weight, thin profile, low-radiation and low driving voltage. Accordingly, the traditional LCDs have been widely applied in small-sized portable electronic products, e.g. cell phones, and personal digital assistants (PDAs). The large-sized LCDs (e.g. LCD TVs) have been commercialized as well. Please refer to FIG. 1, which is a schematic diagram of a prior art LCD. As illustrated in FIG. 1, the prior art LCD 100 includes a display panel 110, a plurality of color-filter arrays 112, a plurality of thin-film transistors (TFTs) 114, a plurality of gate lines 116, and a plurality of data lines 118. Each of the color-filter arrays 112 corresponds to a pixel, and each of the pixels corresponds to a sub-pixel in the display panel 110. The sub-pixels are each provided with a corresponding TFT 114 and a corresponding gate line 116. In the prior art LCD 100, the sub-pixels of the display panel 110 can be switched by the corresponding TFTs 114 to reflect different colors to emit the color light beam.
